

**AMENDMENT No. 03 TO
MASTER SERVICES AGREEMENT FOR GTA DIRECT SERVICES AGREEMENT
Contract # 98000-GTA Direct-CONTRACT-4666-ACC,
formerly 98000-GTA Direct-CONTRACT-4666-GPW**

This Amendment No. 03 is made this 30th day of September _____ 2022, by and between the Georgia Technology Authority ("GTA") and Georgia Public Web, Inc. ("Contractor").

WHEREAS, GTA and Contractor entered into that certain Master Service Agreement No. 98000-GTADirect-CONTRACT-4666-GPW effective on September 23, 2020, with respect to certain services to be provided to GTA by Contractor, as more particularly described therein;

WHEREAS, the Agreement has been amended by mutual agreement of GTA and Contractor as follows:

Amendment No. 1, dated September 24, 2020; and
Amendment No. 2, dated May 24, 2021.

WHEREAS, the parties wish to further amend the Agreement to reflect certain changes.

NOW, THEREFORE, in consideration of the premises, the terms and conditions stated herein, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto hereby agree as follows:

1. **Assignment by Contractor and Name Change.** Georgia Public Web, Inc., assigns all of its rights, title, and interest, and delegates all of its obligations and liabilities, in and to the Agreement to Accelecom GA, LLC, and Accelecom GA, LLC accepts such rights, title, and interest, and fully assumes such obligations and liabilities from Georgia Public Web, Inc. (the "Assignment"). GTA hereby consents to the Assignment. All references in the Agreement to Georgia Public Web, Inc. are hereby replaced with Accelecom GA, LLC.
2. **Contract Number.** The Agreement is hereby amended to change the Contract Number from 98000-GTA Direct-CONTRACT-4666-GPW to 98000-GTA Direct-CONTRACT-4666-ACC.
3. **Notice.** Section 14.10 of the MSA is hereby amended to change the Service Provider addressee information to the following:

4. **Definitions.** All capitalized terms used herein and not expressly defined herein shall have the respective meanings given to such terms in the Agreement.
5. **Successors and Assigns.** This Amendment No. 03 shall be binding upon and inure to the benefit of the successors and permitted assigns of the parties hereto.
6. **Entire Agreement.** Except as expressly modified by this Amendment No. 03, the Agreement shall be and remain in full force and effect in accordance with its terms and shall constitute the legal, valid, binding and enforceable obligations of the parties. In the event of any inconsistencies between the Agreement and this Amendment No. 03, the terms of this Amendment No. 03 shall

control. This Amendment No. 03 and the Agreement, collectively, are the complete agreement of the parties and supersede any prior agreements or representations, whether oral or written, with respect thereto.
