

**AMENDMENT No. 05 TO
MASTER SERVICES AGREEMENT FOR GTA DIRECT SERVICES AGREEMENT
Contract # 98000-GTA Direct-CONTRACT-4666-ACC**

This Amendment No. 04 is made this 9th day of May 2023, by and between the **Georgia Technology Authority** ("GTA") and **Accelecom GA, LLC** ("Contractor").

WHEREAS, GTA and Contractor entered into that certain Master Service Agreement No. 98000-GTADirect-CONTRACT-4666-GPW effective on September 23, 2020, with respect to certain services to be provided to GTA by Contractor, as more particularly described therein;

WHEREAS, the Agreement has been amended by mutual agreement of GTA and Contractor as follows:

- Amendment No. 01, dated September 24, 2020;
- Amendment No. 02, dated May 24, 2021;
- Amendment No. 03, dated September 30, 2022 (the "Assignment"); and
- Amendment No. 04, dated February 24, 2023.

WHEREAS, the parties wish to further amend the Agreement to reflect certain changes.

NOW, THEREFORE, in consideration of the premises, the terms and conditions stated herein, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto hereby agree as follows:

1. Service Order: The Agreement is amended by extending the term from July 1, 2023 until June 30, 2024.
2. Definitions. All capitalized terms used herein and not expressly defined herein shall have the respective meanings given to such terms in the Agreement.
3. Successors and Assigns. This Amendment No. 05 shall be binding upon and inure to the benefit of the successors and permitted assigns of the parties hereto.
4. Entire Agreement. Except as expressly modified by this Amendment No. 05, the Agreement shall be and remain in full force and effect in accordance with its terms and shall constitute the legal, valid, binding and enforceable obligations of the parties. In the event of any inconsistencies between the Agreement and this Amendment No. 05, the terms of this Amendment No. 05 shall control. This Amendment No. 05 and the Agreement, collectively, are the complete agreement of the parties and supersede any prior agreements or representations, whether oral or written, with respect thereto.
